Rules regarding Admission:

1. Admission MBA-HRD First List (Gen & Reserved) starts on and from 18th June, 2019
Admission from First List (Gen & Reserved) closes on 9th July, 2019
2. Candidate must show all original documents (from Class X level to Graduation(Honours)/Post Graduation level, Caste Certificate [in case of SC/ST/OBC A & B candidate], CAT /MAT /or any other national level admission test Score along with self attested photocopies of all documents at the time of admission.
3. Each candidate must also submit 2 recent colour passport size photos at the time of admission.
4. Admission is Provisional. For the candidates whose final year result of the qualifying examination is pending, the admission is subject to cancellation if qualifying results are not produced within August, 2019. No refund of fees can be claimed in case of such cancellation of admission.
5. Admission of the candidates from other than University of Calcutta is subject to the approval of the Equivalence Committee under the Registrar, University of Calcutta.
6. No further correspondence will be made in this regard.

7. Fees payable at the time of admission:
